## VILLAGE OF HASKINS WOOD COUNTY, OHIO

### ORDINANCE ESTABLISHING WATER AND SEWER RATES

**WHEREAS**, Article XVIII, Section 3 of the Ohio Constitution provides the authority by which the Village of Haskins may exercise all powers of local self government, and

**WHEREAS**, Article XVIII, Section 4 of the Ohio Constitution authorizes the Village of Haskins to acquire, construct, own, lease and operate a waste water treatment facility and related structures to serve the municipality and its inhabitants, and

**WHEREAS**, the Village of Haskins desires to construct and operate a waste water treatment facility and related structures to serve the municipality and its inhabitants, the costs of which will be paid with the revenue generated from such service, and

**WHEREAS**, Ohio Revised Code Section 729.49 authorizes the Village of Haskins to establish and collect rents and charges for the use of sewers, sewage disposal works and other waste water treatment facilities, and

**WHEREAS**, the Village of Haskins has established water and sewer rates by Ordinance No. 391, approved December 15, 1997, and

**WHEREAS**, the rates to be charged for such services must be amended to secure to financing for said project and meet increased costs for such services.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Haskins, Wood County, Ohio, that:

**Section 1:** Ordinance 391, approved December 15, 1997, shall be amended as follows:  
Rate Schedule:  
There shall be a sewer charge consisting of a fixed charge of Seventy Dollars, (\$70.00), per each single family residential unit equivalent per month.

Ordinance No. \_\_\_\_\_ The water use charge for residential users as established in Village of Haskins Ordinance 391, December 15, 1997 shall remain in effect.

The fixed sewer charge shall be allocated to debt service, operation and maintenance, and reserves, as determined by the Village Council.

Village of Haskins sewer users other than single family residential units shall be rated per Ohio EPA Flow Standards and will receive a monthly bill utilizing a multiplier based upon property usage as compared to a single family residential unit. This multiplier shall be applied to the Seventy Dollars, (\$70.00), per month charge to determine the resulting charge for said property.

A sewer discount of Fifteen Dollars, (\$15.00), shall apply to the flat rate charge for qualified senior citizens that reside within the Village of Haskins and timely file with the Village Utilities Clerk the required discount application.


The rates established herein shall become effective July 1, 2006.


