## ORDINANCE NO 2006-8

### VILLAGE OF HASKINS WOOD COUNTY, OHIO

#### ORDINANCE CLARIFYING WATER AND SEWAGE RATES AND RENTALS, AND DECLARING AN EMERGENCY

**WHEREAS**, the Council of Haskins Village adopted Ordinance Numbers 386-1997 and 405-1998, codified as Section 921.10 and Section 921.06, respectively; and

**WHEREAS**, the Council of Haskins Village adopted Ordinance Number 2006-01 establishing water and sewer rates; and

**WHEREAS**, the Council of Haskins Village adopted Ordinance Number 2006-07, amending Ordinance Number 2006-01, in part; and

**WHEREAS**, several of the above cited Ordinances conflict, in part; and

**WHEREAS**, Council desires consistent sewer and water Ordinances.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Haskins, Wood County, Ohio, that:

**Section 1:** Codified Ordinance 921.10, created by Village of Haskins Ordinance 386-1997, is hereby repealed in its entirety.

**Section 2:** It is recognized by this Council that the water rates established by Village of Haskins Ordinance 391-1997 were amended by Village of Haskins Ordinance 426-1999, codified as 921.33 (a), and that Codified Ordinance 921.33 (a) is hereby repealed. Codified Ordinance 921.33 (b) shall be codified as 921.33.

**Section 3:** That Ordinance 2006-07 amended the unnumbered items 2, 4 and 5 of Ordinance 2006-01, only, and that such was the intention of Council at the time Ordinance 2006-07 was adopted

**Section 4:** This measure is declared to be an emergency measure for the reason that all new sewer and water rates take effect July 1, 2006 and that inconsistencies with respect to such rates would create confusion and uncertainty, both contrary to the intention of Council and detrimental to the health, safety, and welfare of the Village and its residents.




