## ORDINANCE 2007-17

### VILLAGE OF HASKINS WOOD COUNTY, OHIO

#### ORDINANCE ESTABLISHING COMPENSATION FOR PUBLIC OFFICIALS FOR HASKINS VILLAGE

**SECTION 1,** Ordinance O-2007-7 and that all ordinances or parts of ordinance's inconsistent herewith are hereby repealed.

**SECTION 2,** That the compensation of the Mayor shall be the annual sum of \$4810.00 annual payable at the bi-weekly rate of \$185.00.

**SECTION 3,** That the compensation of the Mayor if conducting Mayor's Court shall be the annual sum of \$5993.00 annually payable at a bi-weekly rate of \$230.50.

**SECTION 4,** That the compensation for the Clerk-Treasurer shall be the annual sum of \$28,028.00 payable in bi-weekly installments of \$1,078.00. This salary is paid 60% from the General fund, 20% from the Electric fund and 20% from the Sewer fund.

**SECTION 5,** That the compensation of members of Council shall be the annual sum of \$1200.00 payable in (4) quarterly installments of \$300.00 each.

**SECTION 6,** It is hereby determined that all officials of the village shall be compensated for all expenses incurred while in the service of the community over and above the regular pay schedule set up for their respective office, plus the current IRS rate for mileage. In order to reimbursement by the village for expenses incurred, the village official shall furnish to the Clerk-Treasurer a statement setting for the date involved, miles, traveled, town of or origin and destination, with the paid receipts, before approval for the reimbursement can be obtained by council.
